1. The risk of injuries from activities involved at the ball park is significant, including the potential for permanent paralysis and death. And while particular rules, equipment, and personal discipline may reduce the risk, the risk of serious injury and death does exist; and,
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES, or others, and assumes all and full responsibility for my, and my child's participation; and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If however, I observe any hazard during my presence or participation, I will remove myself and/or my child from participation and will bring such to the attention of the nearest ball park official immediately; and,
4. I, for myself and child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS *For the Love of the Game Sports Del City/Okc Optimist Club, Del City Ball Park/South Side Ball Park @ Davis Field*, their officers, agents, owners, employees, volunteers, lessors, other participants, sponsoring agencies, sponsors, advertisers (releasees), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
